*Francis Neate is the Chair of the Rule of Law Action Group of the International Bar Association, an initiative he pioneered as the main focus of his presidency during his term in 2005 and 2006. He has served the International Bar Association for over 25 years.*

*In his presidency he encouraged Bar Associations and heads of state to respect the Rule of Law.*

*He qualified as a solicitor in England in 1966 and practiced with the firm of Slaughter and May for 33 years prior to joining the investment bank Schroders in 1997 as Group Legal Advisor. He is currently of Counsel with Kirkland and Ellis International LLP.*

*He received a Juris Doctor (JD) from the Chicago Law School in 1963. Previously he had been educated at St. Paul's School, London, and received a BA in Jurisprudence from Oxford University.*

*He is Editor and contributor to "The Rule of Law: Perspectives from around the globe," just published by LexisNexis.*

*He is an avid cricket player, married to Patricia Neate, and the father of three children and grandfather of four.*
